Division 7 – Lana Visser – SO-PA

Utah Lake Spring 4th Grades Field Trips

Division 7, Flotillas 73 and 78, participated in the Utah Lake 4th Grade Spring Field Trips held at Utah Lake State Park. These field trips were held April 25, 27, and May 2, 4 from 10am – 1:30pm. Three school districts (Provo, Nebo, and Alpine) participated, which included 4th Grade students from eleven elementary schools. All total, we talked to over 440 students.

There were eleven different stations, and each class, along with their teacher and adult chaperones, rotated through six stations. The presenters at each station had 25 minutes for their presentation, game, and/or activity with each class. Presentations were focused on Utah Lake's ecology, wildlife and fish habitat, and recreation on Utah Lake. The Utah Lake Authority and Utah Lake State Park sponsored the field trips. Due to our record-breaking snowpack this year, we chose to focus our presentation on water safety when around the streams and rivers along the Wasatch Front. We discussed the dangers presented by our spring runoff, what happens to streams and rivers when runoff is high, and how to stay safe if they are around water that is being affected by spring runoff. To further stress the importance of water safety during spring runoff (or anytime they are participating in water activities on lakes, streams, rivers, or

even the local public swimming pool or backyard pool) we presented a short discussion. on how important it is to wear life jackets, an activity on how to put them on correctly, a discussion and demonstration on Reach, Throw, but Don't Go, and a review of everything we talked about with some of the Coastie Game cards, which the kids loved.

Upon completion of our risk assessment, Jim Losi, Coxswain and owner of Servant boat patrol, instructed all crew members to wear the full Mustang as the ambient temperature was below 60 ° F.

The (2) new 150 HP Honda engines performed as expected at < 3,000 RPM as they needed to be kept at that level in order to complete the break ins.











We departed toward the Bay Bridge and continued to Angel Island. We were welcomed by a few bay seals, and a beautiful grey whale that broke the surface with its magnificent spout. As the sighting was admirable we had to be assured that the mammal was not hurt or entangled.

Official report from Coxswain Jim Losi: "While transiting to Racoon Straights near Angel Island, the crew spotted a gray whale near San Francisco Bay North Channel Lighted Bell Buoy 6 (Figure 1 below). This was confirmed by Morgan Swiggett as Boat Crew Member as he is very familiar with marine life in the Bay. We immediately called Sector SF to report the sighting. We were asked if the whale was involved in an entanglement. We tracked the whale from a safe distance to ensure that it was not entangled and then reported that to Sector."




All crew members practiced several Man Overboard (MOB) drills with adherence to basic safety principles as Morgan Swiggett was applying the 3 points of contacts method (see Morgan below with 2 feet well anchored on the vessel deck and his left hand holding onto the cabin handrail). Please note Morgan's right hand firmly holding Adam's vest during the recovery exercise.



All members also practiced Radio operation at 30 Mn intervals with the Coast Guard to report Servant's location and the condition of the vessel and that of the crew.

Upon returning to base, we responded to a distress call from Chubby, a sailboat that became stranded near Coast Guard Island in Alameda. We quickly located the vessel ~ ½ mile from our position near the Northwest Shore of the Island with the aid of binoculars as we were informed by the Coast Guard that it had lowered its sails, however, finding the vessel was still a bit challenging as there were no Visual Distress Signal (VDS) or Sound Producing Device used by the sailors.



Official report from Coxswain Jim Losi: "As we were RTB to Oakland Yacht Club, we received a broadcast from Sector San Francisco regarding a small sailboat named CHUBBY that was aground on the north end of CGI near the channel day marker. We responded to Sector that we were within eyesight of that area and would investigate. Upon approaching the sailboat CHUBBY we could confirm that she was firmly aground during a dead low tide. The OOD, LT Kenney asked if we could investigate getting a towline to CHUBBY. After several different approaches, it was concluded that the water was just too shallow for a safe approach. We stayed with the sailboat for about 30 minutes to ensure that the crew was and would be safe. LT Kenney released us, but Adam Kovalevsky kept in periodic contact with the skipper of CHUBBY until such time it was known that the skipper and crew were safe. Adam received two letters of appreciation from the skipper and crew of CHUBBY.
